This accessibility statement applies to The Rachel O'Reilly Group website.

This website is run by Rachel O'Reilly and based at University of Birmingham. We want as many people as possible to be able to use this website.

## Preparation of this accessibility statement

This statement was prepared on 15 July 2025. It was last reviewed on 15 July 2025.
